Ide Hill Church of England Voluntary Aided School are pleased to offer places to children from Reception to Year 6. At Ide Hill CE School, we nurture all God's children. We are very proud of the unique combination of spirit, success and setting that makes us such a special place to learn, grow and achieve. Our school is both distinctively Christian and distinctively caring. Surrounded by teachers, volunteers and families, children develop in confidence, resilience and determination through our school vision

At Ide Hill Church of England Primary, we seek the 'abundant life' that Jesus promised (John 10:10) - pupils and staff flourish. From the tiny Saplings in Reception to the mighty Oaks of Year 6, children are nurtured through the learning and experiencing of respect, responsibility and love - and the greatest of these is love (1 Corinthians 13:13). We welcome applications from all members of the community and we ask all parents/guardians to respect the Christian ethos of our school and its importance to our local community.

Our current Published Admission Number for September 2022 is 22.

The admission area for Ide Hill Church of England Primary School is the area within a radius of 2 miles of the school as shown on the Ordnance Survey map available at the school (see Appendix 1).

This admissions policy applies to either:

- a) Children starting School in the Reception Class in September 2022, where September 2022 follows their fourth birthday. Reception children are entitled to a full time place.
- b) Children applying for a place in any class throughout the academic year 2022.

NB: In addition to the Local Authority Application Form Ide Hill Church of England Primary School requires a Supplementary Form (see Appendix 2) to accompany every application which must be returned DIRECTLY to the school. Failure to submit this supplementary form by the Kent County Council Admission Deadline MAY adversely affect your application. Additionally, all applications under faith criteria <u>must</u> also be accompanied by a written reference from your Vicar/Minister (Appendix 2).

#### Admission Criteria

Before the application of oversubscription criteria, children with a statement of special educational need or Education (SSEN), Health and Care plan (EHCP) which names the school will be admitted. As a result of this, the published admission's number will be reduced accordingly.

If the school is over-subscribed, the governing body will apply the following criteria in the following order:-

- 1. Children in Local Authority Care or previously in Local Authority Care (see note 1, Appendix 3)
- 2. Children with siblings attending the school at time of application (see note 2, Appendix 3)
- 3. Children who live within a one mile radius of the school (see note 3, Appendix 3)

In the event of over subscription for the above criteria then, as a Church of England School, preference will be given first to those whose parents / guardians are worshippers at a Church of England Church, and secondly to those who are worshippers at another Christian Church, as evidenced by a returned supplementary form and clerical reference. This is not dissimilar to other church schools admission criteria.

4. Children who live within the admission area and whose parent(s)/guardian(s) are regular worshippers at their Church of England Parish Church (see note 4, Appendix 3).

Faith priority places are offered in the following order:

- Parents who attend church twice a month and have done so for a period of not less than two years.
- Parents who attend church twice a month and have done so for a period of not less than one year.
- Parents who attend church on at least a monthly basis and have done so for a period of not less than two
  years.
- Parents who attend church on at least a monthly basis and have done so for a period of not less than one year.

This must be evidenced by completion of the Supplementary Church Form (**Appendix 2**) and endorsed with a clerical reference, including any relevant additional information from your Vicar/Minister (**Appendix 2**). It is the applicant's responsibility to ensure that both the Supplementary Church Form and the clerical reference are submitted to the School by the deadline. If either of these forms is not submitted by the deadline, your child will not be considered eligible under faith criteria.

5. Children who live within the admission area and whose parent(s)/guardian(s) are regular worshippers at other Christian Churches.

Faith priority places are offered in the following order:

- Parents who attend church twice a month and have done so for a period of not less than two years.
- Parents who attend church twice a month and have done so for a period of not less than one year.
- Parents who attend church on at least a monthly basis and have done so for a period of not less than two years.
- Parents who attend church on at least a monthly basis and have done so for a period of not less than one year.

This must be evidenced by completion of the Supplementary Form (Appendix 2) and endorsed with a clerical reference, including any relevant additional information from your Vicar/Minister (Appendix 2). It is the applicant's responsibility to ensure that both the Supplementary Church Form and the clerical reference are submitted to the School by the deadline. If either of these forms is not submitted by the deadline, your child will not be considered eligible under faith criteria.

- 6. Children who live within the admission area, whose parent(s)/guardian(s) are not church worshippers, but would like their child to be educated at a Church of England Voluntary Aided School.
- 7. Children who live outside the admission area whose parent(s)/guardian(s) are regular worshippers at their Church of England Parish Church. This requires endorsement by the Priest/Minister of your attendance at Church.

Faith priority places are offered in the following order:

- Parents who attend church twice a month and have done so for a period of not less than two years.
- Parents who attend church twice a month and have done so for a period of not less than one year.

- Parents who attend church on at least a monthly basis and have done so for a period of not less than two
  years.
- Parents who attend church on at least a monthly basis and have done so for a period of not less than one year.

This must be evidenced by completion of the Supplementary Church Form (Appendix 2) and endorsed with a clerical reference, including any relevant additional information from your Vicar/Minister (Appendix 2). It is the applicant's responsibility to ensure that both the Supplementary Church Form and the clerical reference are submitted to the School by the deadline. 8. Children who live outside the admission area and whose parent(s)/guardian(s) are regular worshippers at other Christian Churches. This requires endorsement by the Priest/Minister of your attendance at Church.

Faith priority places are offered in the following order:

- Parents who attend church twice a month and have done so for a period of not less than two years.
- Parents who attend church twice a month and have done so for a period of not less than one year.
- Parents who attend church on at least a monthly basis and have done so for a period of not less than two
  years.
- Parents who attend church on at least a monthly basis and have done so for a period of not less than one year.

This must be evidenced by completion of the Supplementary Form (Appendix 2) and endorsed with a clerical reference, including any relevant additional information from your Vicar/Minister (Appendix 2). It is the applicant's responsibility to ensure that both the Supplementary Form and the clerical reference are submitted to the School by the deadline. If either of these forms is not submitted by the deadline, your child will not be considered eligible under faith criteria.

- 9. Children, who live outside the admission area, whose parent(s)/guardian(s) are not church worshippers but would like their child to be educated at a Church of England Voluntary Aided School who do not meet any of the above criteria. These applications will be ranked by distance.
- 10. All other applications will be ranked by distance.

Tie-breaker: In the event of a tie-breaker, where we have to choose between two or more children in the same category as each other, with the same distance from home to school (as measured by the LA), a decision will be made by drawing lots, which will be carried out by the Admissions Committee, in the presence of an independent witness.



#### APPENDIX 3: NOTES REGARDING OVER SUBSCRIPTION CRITERIA

- 1. Children in Local Authority Care or previously in Local Authority Care a child under the age of 18 years for whom the local authority provides accommodation by agreement with their parents/carers (Section 22 of the Children Act 1989) or who is the subject of a care order under Part IV of the Act. This applies equally to children who immediately after being looked after by the local authority became subject to an adoption, residence or special guardianship order. (As defined by Section 46 of the Adoption and Children Act 2002 or Section 8 or 14A of the Children Act 1989.)
- 2. Siblings children who live as brother and sister in the same house, including natural brothers or sisters, adopted siblings, stepbrothers or sisters and foster brothers or sisters.
- 3. Distance The order of priority will be based on the proximity of home to school with those living nearer having priority. The school uses measurements provided by the Local Authority regarding the proximity of children's homes to school. The Local Authority uses the distance between the child's permanent home address and the school, measured in a straight line using the National Land and Property Gazetteer (NLPG) address point data. Distances are measured from a point defined as within the child's home to a point defined as within the school as specified by NLPG. The same address point on the school site is used for everybody.
- 4. Where the word "worshippers" at a church is used in the criteria, this is to be understood as the affirmation by parent(s)/ guardian(s) of regular attendance at church worship, and requires endorsement by way of a written reference from the Vicar/Minister of the attended church. This must be evidenced by completion of the Supplementary Church Form (Appendix 2) and endorsed with a clerical reference, including any relevant additional information from your Vicar/Minister (Appendix 2). It is the applicant's responsibility to ensure that both the Supplementary Church Form and the clerical reference are submitted to the School by the deadline. If either of these forms is not submitted by the deadline, your child will not be considered eligible under faith criteria.

#### ADMISSION POLICY DEFNITIONS

- 1. Closing Date The closing date for applications for admissions and the offering of places will be in line with that of the Local Authority. Supplementary forms MUST be returned to the school office by the same date. Applications received after this date will be considered in relation to the admissions criteria only if there are spaces. Parents and guardians should note that gaining a place is not dependent on how early the application was made.
- 2. Waiting List Children not offered a place will be put in order on the waiting list in accordance with the admissions criteria, not on a first come first served basis. The waiting list will be re-ranked, in line with the published oversubscription criteria, every time a child is added or removed. The waiting list will remain in operation until the end of the first term (i.e. October half term) at which point it will be dissolved.
- 3. Notification of Decision The Local Authority will inform parents and guardians whether a child has gained a place at this school.
- 4. Right of Appeal If the child has not gained a place at the school and the parents or guardians wish to appeal against that decision, they should first contact the School Office for information on how to proceed.
- 5. Statutory School Age / Deferred Entry The statutory age at which a child must start school is the beginning of the term after which they become five. However, a place will be provided for children in the September following their fourth birthday. Parents may request that the date of admission is deferred until later in the School Year but not beyond the age that they reach compulsory School age or beyond the final term of the School year for which the place was made.
- 6. Full/Part Time basis Parents of children aged four will be able to choose for their child to start school on a full or part time basis (after discussion of specific needs with the Head teacher), however children are required to attend full time in the term they reach compulsory School age.
- 7. In Year Admissions Anyone wishing to apply for a place within the academic year must complete an "In Year Admissions Form" as soon as you wish to be considered for a place. If no spaces are available, you will be placed on the "in year" waiting list. Where the pupil numbers of the year group are over the Published Admission Number, this will be at the discretion of the Headteacher and Governors. Children entering our School under the Sevenoaks "in year fair access" agreement will have priority over children on our "in year" waiting list.
- 8. Admission out of the normal age group Places will normally be offered in the Year Group according to the child's date of birth but a parent may submit an application for a Year Group other than the child's chronological Year Group, for instance where the child is significantly able or where a child has suffered from particular social or medical issues impacting his or her schooling. In addition, the parents of a summer born child (April 1st 31st August) may choose not to send their child until the September following their fifth birthday and may request that they are admitted out of their normal age group. We shall make a decision on the basis of the circumstances of each case and in the best interests of the child concerned. This will include taking account of the parent's views; information about the child's academic, social and emotional development where relevant; their medical history and the views of a medical professional; whether they have previously been educated out of their normal age group; and whether they may naturally have fallen into a lower age group if it were not for being born prematurely. We shall also take into account the views of the Headteacher of the school. Parents must not assume that the decision of one school will transfer with the child to a different school as the decision rests with the individual admission authority. Where a place is refused in a different Year Group but a place is offered in the school, there will be no right of appeal.
